ORDINANCE NO. 1430

AN ORDINANCE AMENDING SECTION 14-209 ENTITLED "CERTAIN TRUCKS PROHIBITED", WITHIN ORDINANCE 1416 TO THE CITY OF PHILLIPSBURG, KANSAS, AS ADOPTED OCTOBER 1, 2018; AND REPEALING SAID SECTION 14-209 AS ADOPTED WITHIN ORDINANCE 1416.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PHILLIPSBURG, KANSAS:

Section 1. That Section 14-209 of Ordinance 1416 of the City of Phillipsburg, Kansas, is hereby amended to read as follows:

14-209. CERTAIN VEHICLES, LARGE TRUCKS, SEMI-TRUCKS, SEMI-TRAILERS, TRACTOR TRAILERS, TRAILERS, TRACTORS, AND BUSES PROHIBITED. (a) No vehicle, or any large truck, semi-truck, semi-trailer, tractor trailer, trailer, tractor, or bus with a gross vehicle weight in excess of 35,000 pounds shall be operated or parked on any of the hard-surfaced streets within the City, except on U.S. Highways 36 and 183.

(b) In order to provide safe City Streets, as well as less maintenance to City Streets the following exceptions to part (a) are allowed: (i) during the process of loading or unloading such vehicle, large truck, semi-truck, semi-trailer, tractor trailer, trailer, tractor, or bus; (ii) during the time such vehicle, large truck, semi-truck, semi-trailer, tractor trailer, trailer, tractor, or bus is used to perform construction on public or private property, routine or emergency maintenance to utilities, transportation facilities, on private or public property; or (iii) during the time such vehicle, large truck, semi-truck, semi-trailer, tractor trailer, trailer, tractor, or bus is used to train or license motor vehicle operators.

For the purpose of this ordinance, the following definitions shall apply:

- A. Bus: A large motor-driven passenger vehicle capable of carrying greater than thirty-five (35) passengers at one time or having a Gross Vehicle Weight in excess of 35,000 pounds, used for the transportation of people for school, church or other public use.
- B. Large Truck: A large motor-driven vehicle which is over nine (9') feet in height, having more than a single rear axle, or having a Gross Vehicle Weight in excess of 35,000 pounds.

Section 2. REPEAL. That Section 14-209 of Ordinance 1416 of the City of Phillipsburg, Kansas, as originally written and adopted October 1, 2018, is hereby repealed.


Section 3. EFFECTIVE DATE. This ordinance shall take effect and be in force from and after its publication in the official city newspaper.


