ORDINANCE NO. 1437

AN ORDINANCE VACATING PART OF CERTAIN UNOPENED PUBLIC STREETS, ALLEYS, AND EASEMENTS WITHIN THE CITY OF PHILLIPSBURG, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PHILLIPSBURG, KANSAS:

WHEREAS, the Planning Commission of Phillipsburg, Kansas, received a request to vacate a portion of certain unopened public streets, alleys, and easements within the City of Phillipsburg, Kansas;

WHEREAS, the Planning Commission held a meeting on November 17, 2021, regarding said request; and,

WHEREAS, the Planning Commission found it advisable to vacate certain unopened public streets, alleys, and easements within the City of Phillipsburg, Kansas.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF PHILLIPSBURG, KANSAS, TO-WIT:

Section 1. That the following described unopened streets, alleys, and easements are hereby vacated:

Sixth Street, north of railroad right of way west of Block 2 Range 7, Lots 7-12, Phillipsburg Original, City of Phillipsburg, Phillips County, Kansas.

Seventh Street, north of railroad right of way east of Block 2 Range 7, Lots 7-12, Phillipsburg Original, City of Phillipsburg, Phillips County, Kansas

B Street, north of railroad right of way south of Block 2 Range 7, Lots 7-12, Phillipsburg Original, City of Phillipsburg, Phillips County, Kansas.


Alley between sixth street and seventh, north of railroad right of way near Block 2 Range 7, Lots 7-12, Phillipsburg Original, City of Phillipsburg, Phillips County, Kansas.

Section 2. This ordinance shall take effect and be in full force from and after its publication in the official newspaper of the City of Phillipsburg, Kansas.

Section 3. That upon passage and publication of this Ordinance, the City Clerk is directed to send an attested copy of this Ordinance to all other taxing subdivisions regarding the vacated area.
