ORDINANCE NO. 1440

AN ORDINANCE AMENDING SECTION 15-403 OF ARTICLE 4 OF CHAPTER 15 OF THE CODE OF THE CITY OF PHILLIPSBURG, KANSAS, 2013; AND REPEALING SAID SECTION 15-403 AS ORIGINALLY ADOPTED, November 18, 2013, WITHIN ORDINANCE 1384. THIS ORDINANCE PERTAINS TO SEWERAGE SYSTEM, NAMELY DESIGNATED USES, IN THE CITY OF PHILLIPSBURG, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PHILLIPSBURG, KANSAS:

Section 1. That Section 15-403 of Article 4 of Chapter 15 of the Code of the City of Phillipsburg, Kansas, 2013, is hereby amended as follows, to-wit:

15-403. SAME; DESIGNATED USES. That portion of the total user charge collected which is designated for operation and maintenance including replacement purposes as established in Section 15-404, shall be credited to two primary accounts as follows:

(a) An account designated for the specific purpose of defraying operation and maintenance costs of the treatment works (Operation and Equipment Account).

(b) An account designated for the specific purpose of ensuring replacement needs over the useful life of the treatment works (Equipment Reserve Account). Credits to the equipment reserve account shall be made as the City Council in its discretion deems necessary.

Section 2. REPEAL. That Section 15-403, SAME; DESIGNATED USES OF Article 4 of Chapter 15 of the Code of the City of Phillipsburg, Kansas, 2013, within Ordinance 1384 as originally adopted is hereby repealed.

Section 3. EFFECTIVE DATE. This ordinance shall take effect and be in force from and after its publication in the official city newspaper.
