ORDINANCE NO. 1439

AN ORDINANCE AMENDING SECTION 15-501 OF ARTICLE 5 OF CHAPTER 15 OF THE CODE OF THE CITY OF PHILLIPSBURG, KANSAS, 2013; AND REPEALING SAID SECTION 15-501 AS ORIGINALLY ADOPTED, November 18, 2013 WITHIN ORDINANCE 1384. THIS ORDINANCE PERTAINS TO SEWER USE CHARGES, NAMELY CONNECTION CHARGES, IN THE CITY OF PHILLIPSBURG, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PHILLIPSBURG, KANSAS:

Section 1. That Section 15-501 of Article 5 of Chapter 15 of the Code of the City of Phillipsburg, Kansas, 2013, is hereby amended as follows, to-wit:

15-501. CONNECTION CHARGE. (a) No property within the city limits shall be connected to a sanitary sewer constructed until a sewer connection charge of \$25.00 has been paid.

(b) In addition to subsection (a), no property within the city limits shall be connected to the East Sewer Extension Project on or after December 1, 1996, until the special assessment fee for (i) residential use property in the amount of \$5,000.00 and bond interests has been paid, or (ii) commercial use property in the amount of \$10,000.00 and bond interest has been paid.


Section 2. REPEAL. That Section 15-501, CONNECTION CHARGE, of Article 5 of Chapter 15 of the Code of the City of Phillipsburg, Kansas, 2013, within Ordinance 1384 as originally adopted is hereby repealed.


Section 3. EFFECTIVE DATE. This ordinance shall take effect and be in force from and after its publication in the official city newspaper.
