ORDINANCE NO. 1454

AN ORDINANCE AMENDING SUBSECTION (B) OF SECTION 14-224 OF ORDINANCE 1384 AS ORIGINALLY WRITTEN, WHICH PERTAINS TO GOLF CART USE REGULATIONS WITHIN THE CITY OF PHILLIPSBURG KANSAS, AND REPEALING SAID SUBSECTION (B) OF SECTION 14-224 OF ORDINANCE 1384 AS ORIGINALLY ADOPTED.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PHILLIPSBURG, KANSAS:

Section 1. That subsection (b) of section 14-224 of ordinance 1384 of the City of Phillipsburg, Kansas, is hereby amended to read as follows :

Same; license required. No person shall operate a special purpose vehicle (utility all-terrain vehicle, golf cart, micro utility truck, and work-site utility vehicle) on any public highway, street, road or alley within the corporate limits of the city unless such person has a valid driver's license and must comply with all restrictions set forth by Kansas Department of Motor Vehicles. Violation of this section is punishable by a fine of not more than \$1,000.00 or by imprisonment for not more than six months or by the such fine and imprisonment. (ord. 1355; code 2010)

Section 2. That section 14-224 of ordinance 1384 as originally written and approved on November 13, 2013 is hereby repealed.


Section 3. This ordinance shall take effect and be in full force from and after its publication in the official newspaper of the City of Phillipsburg, Kansas.
