ORDINANCE NO. 1365

AN ORDINANCE AMENDING SECTION 3-102 OF THE CODE OF THE CITY OF PHILLIPSBURG, KANSAS, 2010, AND REPEALING SAID SECTION 3-102 AS ORIGINALLY ADOPTED; AND REPEALING SECTION 3-206 ENTIRELY OF THE CODE OF THE CITY OF PHILLIPSBURG, KANSAS, 2010, AS ORIGINALLY ADOPTED, HOWEVER RESERVING SAID SECTION NUMBER 3-206 FOR FUTURE USE. THIS ORDINANCE PERTAINS TO ALCOHOLIC LIQUOR RESTRICTION ON LOCATION.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PHILLIPSBURG, KANSAS:

Section 1. That Section 3-102 of the Code to the City of Phillipsburg, Kansas, is hereby amended to read as follows:

3-102. RESTRICTION ON LOCATION. (a) No alcoholic liquor shall be sold by a person holding a license or permit from the city whose place of business or other premises are located within 200 feet of any church, school, nursing home, library, or hospital, said distance to be measured from the nearest property line of such church, school, nursing home, library, or hospital to the nearest portion of the building occupied by the premises.

(b) The distance location of subsection (a) above shall not apply to a club, drinking establishment, restaurant, caterer or temporary permit holder.

(c) No license or permit shall be issued for the sale of alcoholic liquor if the building or use does not meet the zoning ordinance requirements of the city or conflicts with other city laws, including building and health codes.

Section 2. That Section 3-102 entitled RESTRICTION ON LOCATION, of the Code of the City of Phillipsburg, Kansas, 2010, as originally adopted is hereby repealed.

Section 3. That Section 3-206 entitled RESTRICTION ON LOCATION, of the Code to the City of Phillipsburg, Kansas, 2010, is hereby repealed and said Section number 3-206 is hereby reserved for future use.

Section 4. That this ordinance shall take effect and be in full force from and after its publication in the official newspaper of the City of Phillipsburg, Kansas.
