Section 1. That the following described land is hereby annexed and made a part of the City of Phillipsburg, Kansas:



Commencing at the Southwest Corner of Lot 94, Replat of Sunrise Subdivision South of Fischer Drive in Phillipsburg, Phillips County, Kansas, Thence West 310 feet, thence South 50 feet to the Point of Beginning; thence South 100 feet, thence West 105 feet, thence North 100 feet, thence East 105 feet to the Point of Beginning.




