ORDINANCE NO. 1343

AN ORDINANCE AMENDING ORDINANCE 1305 OF THE CITY OF
PHILLIPSBURG, KANSAS, AND REPEALING SAID ORDINANCE 1305
AS ORIGINALLY ADOPTED. THIS ORDINANCE PERTAINS TO SOLID
WASTE CHARGES.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PHILLIPSBURG,
KANSAS:

Section 1. That Ordinance 1305 of the City of Phillipsburg,
Kansas, is hereby amended to read as follows:

18-613. SOLID WASTE CHARGES.

The solid waste charges shall be levied against each
householder, single dwelling unit, multi-family unit, business,
institution, and industry, motels, and multi-business units
in the city each month for the collection and disposition of
solid waste. The failure to pay shall be cause for discontinuing
all collections and solid waste services and the city reserves
the right to discontinue any solid waste service to any customer
upon the failure to pay the full charges for the solid waste
services.

The following charges shall apply:

- (a) Single dwelling units - \$16.50 per month;
- (b) Multi-family units - \$16.50 for the first unit and
\$15.00 for each additional unit, per month, when the charges are
billed and paid by the owner or operator of the unit.
- (c) Businesses, institutions and industries shall be
charged a minimum charge of \$24.00 per month for one day per week
pickup for those businesses inside city limits, and for each
additional day per week pickup, there is an additional \$24.00
charge.
- (d) Motels will be charged at the rate of \$9.90 for the
first room and \$0.90 per additional room per month for one day a
week pickup. For each additional removal per week, there will be
an additional charge of \$9.90 for the first room and \$0.90 per
additional room per month.
- (e) Multi-Business units will be charged at the rate of
\$24.00 per month for the first business unit and \$22.50 per month
for each additional unit when the charges are billed and paid by
the owner or operator of the multi-business unit. Said billing

arrangement shall apply for one day per week pickup. Each additional daily pickup per week will require an additional charge of \$24.00 per month for the first business unit and \$22.50 for each additional business unit.

(f) All solid waste collection outside the corporate limits of the city will be charged at one and one-half times the rate charged inside the city limits.

(g) There will be additional charges when trash exceeds the average pickup for businesses of comparable size.

(h) All rural city water users shall pay to the city a solid waste fee at one and one-half times the city rate unless Phillips County is collecting and disposing of the solid waste, or solid waste is being disposed of in an approved landfill.

Section 2. That Section 18-613, SOLID WASTE CHARGES, of Ordinance 1305 of the City of Phillipsburg, Kansas, as originally adopted is hereby repealed.


Section 3. The solid waste charges established by the Ordinance shall take effect on the date as indicated in the users first solid waste billing statement prepared by the City after April 1, 2008.

Section 4. This Ordinance shall take effect and be in full force from and after its publication in the official newspaper of the City of Phillipsburg, Kansas.
