ORDINANCE NO. 1336

AN ORDINANCE AMENDING ORDINANCE 1322 OF THE CITY OF
PHILLIPSBURG, KANSAS, AND REPEALING SAID ORDINANCE 1322
AS ORIGINALLY ADOPTED. THIS ORDINANCE PERTAINS TO WATER
RATES CHARGED BY THE CITY OF PHILLIPSBURG, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PHILLIPSBURG,
KANSAS:

Section 1. That Ordinance 1322 of the City of Phillipsburg,
Kansas, is hereby amended to read as follows:

18-301. WATER RATES.

The rates to be charged per month for water from the
municipal water utility system are as follows:

(a) Business and Residential Use -

The First 1,000 gallons or less per month - \$12.00 minimum charge
1,001 gallons to 8,000 gallons per month - \$3.82 per thousand
8,001 gallons to 15,000 gallons per month - \$3.90 per thousand
15,000 gallons and over per month - \$3.96 per thousand

(b) All treated water sold for industrial use shall be at
the rate of \$12.00 for the first 1,000 gallons or less per month;
\$2.28 per thousand gallons per month for 1,001 gallons to
2,000,000 gallons; \$2.06 per thousand per month for water sold
over 2,000,001 gallons.

(c) All untreated (Raw) water sold for industrial use shall
be at the rate of \$12.00 for the first 1,000 gallons or less per
month and \$1.52 per thousand gallons per month for water sold
over 1,001 gallons.

(d) The rates for water sold to persons outside the city
limits for residential or business, except as provided by
specific contract with the user, uses are as follows:

1. First 1,000 gallons or less per month - \$24.00
2. 1,001 gallons to 8,000 gallons per month - \$5.73 per thousand
3. 8,000 gallons to 15,000 gallons per month - \$5.85 per thousand
4. 15,001 gallons and over per month - \$5.94 per thousand

(e) In addition to the above charges there will be added
all of those Kansas state taxes and Kansas state special

assessment taxes mandated to be charged by the City for the State of Kansas.

Section 2. That Section 18-301, WATER RATES, of Ordinance 1322 of the City of Phillipsburg, Kansas, as originally adopted is hereby repealed.

Section 3. The water rates established by this Ordinance shall take effect on the date as indicated in the users first water billing statement prepared by the City after May 1, 2007.

Section 4. This Ordinance shall take effect and be in full force from and after its publication in the official newspaper of the City of Phillipsburg, Kansas.



